Will Argentina launch its first liquefied natural gas project in 4 years?

HOUSTON, March 19 (Reuters) - Argentina could inaugurate its first liquefied natural gas (LNG) project in four years if economic and energy reforms proposed by President Javier Milei are passed by congress soon, the CEO of producer Tecpetrol said on Tuesday.

Why have Argentine energy shares soared so much?

Share prices for many Argentine energy companies have more than doubled since Milei's victory, building on explosive growth in recent years. Shares in Vista Energy, which has benefited from its narrow focus on Vaca Muerta's shale oil to become Argentina's largest non-integrated producer, have soared almost 700 per cent in the past three years.

Could Argentina be a major energy exporter?

In a remote, scrubby stretch of Patagonian desert, Argentina's future as a major energy exporter is taking shape. A team of 10, working in September in a corner of the vast Vaca Muerta shale formation in the western province of Neuquén, hauled 75cm-thick carbon steel tubes into place and welded them together to build an oil pipeline.

How will Argentina regain energy self-sufficiency?

Get ahead with daily markets updates. In its urgent effort to regain energy self-sufficiency, Argentina wants more investment in its huge Patagonian shale deposits and its plentiful renewable sources such as wind and sun. It also has high hopes for its nuclear power industry.

Does Argentina have a shale gas surplus?

Argentina sits on one of the world's largest shale gas reserves, but the cash-strapped nation still must import fuel to generate electricity. Its energy deficit last year was estimated at some \$5 billion.

Does Argentina need a new gas pipeline?

Argentina needs fresh financing for several proposed projects, such as a \$2.5bn pipeline towards Brazil and a \$30bn liquefied natural gas terminal on the coast. Austerity-focused Milei has ruled out public financing. "There's a lot more uncertainty in gas," says Daniel Dreizzen, managing director of consultancy Aleph energy.
