When did the British Virgin Islands Electricity Corporation become a corporation?

The British Virgin Islands Electricity Corporation Ordinance No. 7 of 1978 was legislated to provide for the establishment of a Statutory Corporation, known as the British Virgin Islands Electricity Corporation. This Ordinance came into effect in January of 1979.

What are the main functions of the British Virgin Islands corporation?

The major functions of the Corporation are the generation, transmission, supply, distribution and sale of electricity throughout the British Virgin Islands. The Corporation is made up of a Chairman, four ordinary members and two Ex-officio members all appointed by the Cabinet.

How does Peter Island generate electricity?

The outer islands already use renewable resources to produce energy. Peter Island generates 70% of its electricity from two Wind Energy Solutions hybrid turbines rated at 250 kilowatts (kW) each, backed-up by diesel generators. Cooper Island generates more than 75% of its electric needs from solar PV and uses solar water heating.
