

Can you get a solar loan in Canada?

Canada Greener Homes Loan - As part of the Greener Homes Initiative, eligible homeowners can also receive a 10-year interest free loan of \$5,000 and up to \$40,000 to help finance their solar system. There are currently 7 solar energy incentives available in Alberta. This includes 5 rebates and 2 financing programs.

Does Canada offer solar incentives?

Canada's federal government provides three solar incentives: two of which are exclusively commercial and one which is residential. It also offers investment tax credits in a variety of clean energy sectors. a. The Greener Homes Rebate

Can I buy a solar voltaic system in Canada?

This includes 1 rebate and 1 financing program. Canada Greener Homes Grant - The federal government currently offers Canadian homeowners a grant of \$1.00 per watt for the purchase of a solar voltaic system,up to a total of \$5,000. To be eligible, you'll need to register with the Greener Homes Initiative.
