How much does it cost to install solar panels?

You can usually expect to pay between £300 for each dayof solar panel installation. Usually,there will be two people installing your system,which comes to around £600 per day. Solar panels are usually installed on your roof in a single day,but larger systems will often take more than one day to install,which can cause labour costs to climb.

Do you own solar panels?

You OWNthe solar panels. Under these schemes, you pay for solar panels over a fixed period, say 20 years. There are no upfront costs, and instead you pay a monthly fee, which usually covers the solar panel and battery installation, repairs and maintenance.

Why do solar panels cost so much?

The only additional cost factors are the upfront costs of installing a solar system and the fossil fuel electricity costs needed when solar doesn't cover all energy needs. While the most efficient solar panels on the market today have efficiency ratings as high as 23%, the majority of panels range from a 15% to 20% efficiency rate.

How do I finance a solar PV installation?

The most cost-effective way to finance the installation of solar PV panels is to pay in full using your own savings. If you're unable to pay upfront, you could consider a loan or remortgaging.
