

# Does the National Development and Reform Commission regulate solar power generation

What is the purpose of the National Development & Reform Commission?

To encourage the construction of offshore wind power bases and promote the deployment of offshore wind power in deep-water and offshore areas. (National Development and Reform Commission, 2022b) Steadily promote structural transformation and accelerate the transformation of green and low-carbon energy.

What is the growth rate of wind and photovoltaic power in China?

During the 12th Five Year Plan for Economic and Social Development of the People's Republic of China (12th Five-Year Plan) period, the combined annual power generation of wind and photovoltaic (PV) power in China accounted for less than 4%, annual growth of about 0.6% (Fig. 1). Fig. 1.

How much power is generated by solar and wind power?

The annual cumulative power generation of wind and PV power reached 978.5 billion kWh, up 35% year-on-year, accounting for 11.7% of the total power generation, an increase of 2.2 percentage point over the previous year (Fig. 1). 3. How many solar panels are installed in the US in 2021?

According to the U.S. Energy Information Administration (EIA), the installed capacity of new residential roof PV in the US in 2021 reached 4.3 GW, an increase of 29%. California was the largest market for rooftop PV in the US last year (2020), accounting for about 1/3 of all new installations.

What is a community solar partnership?

In addition, the U.S. Department of Energy announced a new "National Community Solar Partnership", which aims to have community solar projects deliver 26 GW of power and generate \$1 billion in revenue by 2025. The total installed capacity will reach 30 GW by 2030.

How to promote a high-quality development of wind and solar power?

To comprehensively promote large-scale and high-quality development of wind and solar power, give priority to local and nearby development and utilization, speed up the construction of decentralized wind and distributed PV power in load centers and surrounding areas, and promote the application of low-wind wind power technologies.
