Who owns Mercuria?

Mercuria was created after Mr Dunand and Daniel Jaeggi,former traders at Goldman Sachs,took control in 2004 of J+S,a small trading house that had a dominant position importing Russian crude oil to refineries in Poland. The owners of that business were Gregory Jankilevitsch and Wiaczeslaw Smolokowski.

Who are Mercuria's top executives?

The three top executives at Mercuria have increased their holding in the Swiss-based commodity trader since the start of the year,according to a filing with US regulators. Co-founders Marco Dunand and Daniel Jaeggi plus head of trading Magid Shenoudacontrolled just over 41 per cent of parent company in July,up from 34.4 per cent in January.

Who owns Mercuria & J&S Group?

Prior to this, Mercuria was assumed control of J&S Group, which was named after the Polish businessmen Gregory Jankilevitsch and Wiaczeslaw Smolokowski. They and their affiliates joined as founders of Mercuria, and they remain as shareholders today.
