Leaders of 23 EU member states and the European Commission have signed a Solar Charter pledging to step up financing opportunities, skills capacity and to address unfair competition in the bloc during an Energy Council.

A draft 'European Solar Charter' set to be signed by the European Commission and most EU countries on Monday said governments would consider using more EU funding and national aid to back solar manufacturing projects.

However, the bulk of the demand for solar modules in Europe is covered by imports. Currently, 97% of the solar panels imported into the EU come from China. The charter sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

Will European solar panels be able to trade with China?

European solar panel manufacturers have previously asked the EU to consider trade safeguards on Chinese imports, but Brussels and governments including Germany have warned broad curbs on Chinese supply could stunt Europe's fast expansion of clean energy.
