On April 29, 2019, Enel Green Power inaugurated a 34 megawatts (MW) solar power plant in Ngonye, a town south of Lusaka, the Zambian capital. The facility provides electricity to the Zambian grid for the equivalent of 7.8 US dollars per kilowatt hour. Enel Green Power is taking care of this work on the basis of a 25-year power purchase agreement.

Enel"s renewable arm Enel Green Power started construction of the 34 MW [1] solar PV facility, which is located in southern Zambia and, once completed, is expected to produce around 70 GWh per year, avoiding the annual emission of over 45,000 tons of CO 2 into the atmosphere; Enel will be investing approximately 40 million US dollars in the construction ...

The Ngonye Falls Power Station, is a planned hydroelectric power station across the Zambezi River in Zambia. The power station will have maximum generating capacity of 180 megawatts (240,000 hp) when completely developed. The energy will be sold to ZESCO under a long-term power purchase agreement. [1] It is named after the nearby Ngonye Falls.

The 3km long concrete lined power canal is 11m deep, with a maximum water depth of 9m and capacity to convey 1100m3/s. At the end of the canal, a forebay is formed from the natural landscape and retaining dams. The forebay holds a buffer of water for the power station to maintain constant flow through the turbines.

Enel Green Power ("EGP"), the Enel Group"s global business line dedicated to renewable energy, has started operations of the 34 MW1 Ngonye solar PV plant, which is the Group"s first power plant in Zambia.
