Will Saur industry merge with Nijhuis?

As a result, Saur Industrie, Unidro and Econvert will gradually merge with Nijhuis over the coming months to create the new Industry Division with effect from January 2021. It is therefore clear that this strategic investment by the Saur Group puts industry at the heart of its growth model.

Who will lead Nijhuis industrial water?

Together with Unidro's and Econvert's existing strong management teams, Menno Holterman, Nijhuis' current CEO, will lead Saur Industrial Water division headquartered in the Netherlands, while Ronald Ruijtenberg, Nijhuis' current CFO, will become the Industrial Water CFO.

Who is the new CEO of Saur Group?
