Will a new European Solar charter support EU photovoltaic manufacturing?

Leaders pledge extended support with new European Solar Charter to back European EU photovoltaic manufacturing. Leaders of 23 EU member states and the European Commission have signed a Solar Charter pledging to step up financing opportunities, skills capacity and to address unfair competition in the bloc during an Energy Council.

What is the European solar PV industry alliance?

The European Solar PV Industry Alliance was by the Commission together with industrial actors, research institutes, associations and other relevant parties on 9 December 2022 to support the objectives of the EU's Solar Energy Strategy.

What is the EU photovoltaic charter?

Signed today in the margins of the informal Energy Council meeting by the Commission - represented by EU Commissioner for Energy Kadri Simson - energy ministers from 23 EU countries and industry representatives, the charter sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

What is the EU solar charter?

Building on the 2022 EU Solar Strategy,the EU Solar Charter reinforces the reality that solar PV is now a mainstream energy technology. Europe,and the world,is banking on solar to guide us out of the climate and energy crisis towards a new era of green prosperity and security. The Solar Charter is an important moment of recognition.

Who signed the EU solar charter?

Today,23 EU Energy Ministers,as well as around 100 representatives from the European solar sectorsigned the EU Solar Charter (here). The Charter was signed during an Informal Energy Ministerial in Brussels and is a commitment from governments and the sector to support European solar manufacturing.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.
