

What is a PV inspection reference?

This inspection reference details most of the issues that relate to the PV system during the inspection process.

Are all items outlined in this section relevant to a PV system?

Not all items outlined in this section are relevant to each PV system. This inspection reference details most of the issues that relate to the PV system during the inspection process. All California Electrical Code (CEC), California Residential Code (CRC), California Building Code (CBC) and California Fire Code (CFC) references are noted.

Should solar energy systems be inspected?

Yes, solar energy systems should be inspected annually. Can I alter the checklist? This checklist is provided as an example only. Other maintenance information may have been provided when the system was first installed. Electricians may also customise this form to suit their needs.

What is a solar site survey checklist?

This solar site survey checklist can be used to determine if a commercial or residential property is suitable for installing solar panels. During site visits, site surveyors can use this checklist to collect information about the site and its roofing, note their observations during assessments, and capture photos and videos of the area.

What do you need to know about a PV system?

PV system markings, labels and signs according to the approved plan. Connection of the PV system to the grounding electrode system according to the approved plan. Access and working space for operation and maintenance of PV equipment such as inverters, disconnecting means and panelboards (not required for PV modules) (CEC 110.26).

Where can I find a guideline for PV systems?
