

What is a photovoltaic system standard?

Many organizations have established standards that address photovoltaic (PV) system component safety, design, installation, and monitoring. Standards are norms or requirements that establish a basis for the common understanding and judgment of materials, products, and processes.

What is the domestic solar PV scheme?

The Domestic Solar PV Scheme operates under the Microgeneration Support Scheme(MSS) and provides a grant towards the purchase and installation of a solar PV system for homeowners. This takes the form of a once-off payment to a homeowner based on the installation of products which meet the requirements of the Scheme.

What are the regulatory levels for photovoltaic systems?

At least three regulatory levels for the production, installation, operation and end of life of photovoltaic systems can be considered. Additionally, the Life Cycle Assessment methodology is also regulated by standards. In this chapter, the three levels are presented.

Do I need to meter a photovoltaic system?

It is assumed that aluminum framed photovoltaic (PV) panels mounted on a "post" and rail mounting system, the most common in the industry today, will be installed by the homeowner. While metering the system is encouraged, the specification does not address system wiring elements for associated system sensors or monitoring equipment.

Are PV modules compliant with building regulations?

5.5.4 Where mounting systems are certified or listed using a named PV module or modules then only those modules shall be used. The system is compliant with current Building Regulations for weather-tightness, fire and wind resistance.

How much weight does a PV system add to a roof?

A conventional PV system that includes racking materials will add approximately 6 pounds per square foot of dead load to the roof or structure, though actual weights can vary for different types of systems. Wind will add live loads; the magnitude of live loads will depend on the geographic region and the final PV system.
