To accelerate the growth of a commercially viable solar energy industry to make this system available to the public as an option that can reduce the fossil fuel consumption and costs to the Government, each government agency and instrumentality, including all branches of government, shall install solar ...

This program opened in 2022, and the application window closed in October of the same year. The innovative financing program offered Virgin Island resident's loans of up to \$30,000 to use towards the installation of solar photovoltaic (PV), and solar PV systems built in conjunction with battery storage.
