

## Tax rate for photovoltaic panels exported to the United States

What are solar panel import tariffs?

Solar panel import tariffs are primarily intended to support the development of a new U.S.-based solar module manufacturing supply chain, which is financially backed by the Inflation Reduction Act. This act introduces a series of tax credits designed to bolster domestic manufacturers. For solar modules, the credits are as follows:

How will tariffs affect solar cells in 2024?

In 2024,tariffs for electric vehicle battery cells will increase to 25%, with energy storage tariffs following suit in 2026. The direct import of solar cells from China was less than 1% in 2021, underscoring the limited direct impact on solar cells these tariffs may have in the U.S. market.

What if China imposes new solar tariffs on imports from Southeast Asia?

When the presidential moratorium on new solar tariffs on imports from Southeast Asia expires next June, imports of solar cells and modules from these five companies will be subject to the tariffs faced by Chinese solar manufacturers, with the tariff level ranging from 50 percent to 250 percent of the import value.

How much would a solar cell cost if imported from China?

If one were to import solar cells from China today, they would cost a few cents to a nickel per watt. With this increase from 25% to 50% - a solar cell priced at five cents per watt would see its tariff increase from \$0.0125/Wdc to \$0.025/Wdc.

Would the US have installed more solar without tariffs?

Will China's solar tariffs affect the US market?

The direct import of solar cells from China was less than 1% in 2021,underscoring the limited direct impacton solar cells these tariffs may have in the U.S. market. Instead,the majority of solar cells used in the US are sourced from regions like Southeast Asia,which offers similar pricing without the tariffs imposed on Chinese products.
