More recently, an attack inside Moroccan-controlled Western Sahara has highlighted the potential for further military escalation. On May 20, an alleged bomb attack reportedly targeted a segment of a 100-kilometer conveyor belt used by Morocco to export phosphates from a mine located deep within Western Sahara to the coast.

The petroleum products arriving in Western Sahara serve primarily to fuel vehicles, engines and vessels that take part in the illegal plunder of the territory, or are used for military purposes by the Moroccan army. The total quantity of oil transported into occupied Western Sahara during 2022 is estimated at 502,000 tonnes.
