What goods are classified under Class 20?

The following goods are also classified under Class 20: Letter boxes not of metal or masonry. Therefore, Trademark Class 20 includes mainly furniture and its parts and plastic goods, not included in other classes. The following goods must NOT be classified under Class 20:

What companies have Trademarks under Class 42?

Companies with trademarks under trademark class 42 include Canva, AGRIAN, and JIFF (parenting skills software). Services for providing food and drink; temporary accommodation. Companies with trademarks under trademark class 43 include McDonald's, Burger King, and KFC.

What are the requirements for energy labels & Fiches?

Suppliers must produce energy labels and fiches in accordance with the regulations, and the supporting technical documentation, allowing their accuracy to be assessed. They must also: Energy labels for certain products are being gradually re-scaled to display A - G energy rating classes instead of A+++ - G energy rating classes.

What is a trademark's specification?

This statement is usually referred to as the 'specification'. On a global scale, Intellectual Property Offices use a trademark classification system referred to as the Nice Classification. The Nice Classification puts types of services and goods into groups or classes intended to make the trademark classification process much simpler.
