Offshore wind projects approved recently are expected to operate with 'negative subsidies' - paying money back to the government. This money will be used to reduce household energy bills as the farms begin producing power in the mid-2020s.

Can offshore wind farms help lower energy bills?

Offshore wind farms in the UK could reduce household energy billsby producing electricity very cheaply. This cheap electricitygenerated from renewable energy projects, including offshore wind and solar farms, has been subsidized by government support schemes.

Why do wind producers switch off a government subsidy?

Wind producers on newer government subsidy contracts are paid a fixed price, generally below current market rates, to generate electricity. By switching off, producers may therefore be able to make rates well above their fixed prices.

What is a federal subsidy for wind?

The primary federal subsidy for wind is a tax credit known as the production tax credit,or PTC,which offers wind facilities and some other renewables a small tax credit for every kilowatt hour of energy produced over a farm's first decade.

In 2022, consumers paid £215 million to turn wind farms off, and £717 million to buy gas-powered electricity to make up the difference, according to figures from the UK Wind Curtailment Monitor.
